- The Ammonium Bicarbonate food grade is manufactured using a synthetic process.
- This is a continuous process in a closed plant
- The raw materials of ammonia and carbon dioxide are reacted and then concentrated until the required density is reached.
- The crystalline product is separated by centrifuge and dried.
- The dried product is blended with the additive Magnesium Carbonate.
- The process is controlled by an automatic system with periodic testing and adjustments performed by the operators.
- The product is packaged in a closed line, equipped with a metal detector.

#### Manufacturing Information

- The Ammonium Bicarbonate sold by Esseco USA has not been irradiated.
- The product is manufactured using current Good Manufacturing Practices (cGMP).
