- The Food grade Potassium Carbonate is manufactured using a synthetic process.
- This is a continuous process in a closed and dedicated plant.
- The raw materials of carbon dioxide, methane, air, and KOH solution are reacted and dried.
- The crystalline product is separated by spray dryer reactor, screened, and packaged.
- The process is controlled by an automatic system with periodic testing and adjustments performed by the operators.
- The product is packaged in a closed and dedicated line, equipped with a metal detector.

### Manufacturing Information

- The product is not treated with ionizing radiation during the production process and is not treated with any ingredient treated with ionizing radiation.
- The product is manufactured using current Good Manufacturing Practices (cGMP).

### Quality System

- The plant maintains a FSSC 22000 Certification from Global Food Safety Initiative(GFSI).
- The plant maintains an ISO 9001:2015 Certification.
- The plant has an FDA registration number of 13071011806.





# TO WHOM IT MAY CONCERN



The events of September 11, 2001, highlighted the need to enhance the security of the infrastructure of the United States, including the food supply. Congress responded by enacting the Bioterrorism Act (Public Law 107-188), which was signed into law on June 12, 2002. 

Esseco USA LLC is in full compliance with Section 306.


