- All the Sodium Sulfite sold by Esseco USA is produced by Esseco srl in Italy and is packaged on pallets that have been heat treated and made from European wood. No fungicides including 2,4,6 tribromophenol (TBP) or 2,4,6 trichlorophenol (TCP) are used on any pallets for this product.
- All the Sodium Sulfite that is sold in 50 lb bags by Esseco USA has gone through a metal detection device when it was packaged by Esseco Srl in Trecate, Italy.

• The Food/HP and Photo Grade of Sodium Sulfite sold by Esseco USA meets all of the product specification requirements. The product may at times contain very small quantities of off-color yellow, gray, brown, or black particulates. Process

- The Food/HP and Photo grade of Sodium Sulfite is manufactured using a synthetic process.
- This is a continuous process in a closed and dedicated plant.
- The raw materials of sulfur dioxide and sodium hydroxide or sodium carbonate are reacted and then concentrated into a slurry until the required density is reached.
- The crystalline product is separated by centrifuge, screened, and dried.
- The process is controlled by an automatic system with periodic testing and adjustments performed by the operators.
- The product is packaged in a closed and dedicated line, equipped with a metal detector (sensitivity: 2.5 mm of ferrous, non-ferrous, and stainless steel).

Manufacturing Information

- The product is not treated with ionizing radiation during the production process and is not treated with any ingredient treated with ionizing radiation.
- The product is manufactured using current Good Manufacturing Practices (cGMP).
- The Food/HP and Photo Grade of Sodium Sulfite sold by Esseco USA, and the raw materials used to produce it, have not been tested on animals.



Diagramma di flusso







Diagramma di flusso






